The award is named after the late Elizabeth McDonald, who was a prominent figure in industrial hygiene within British Columbia.

To be eligible for this award, nominees must be an AIHA BC Yukon Local Section member in good standing. **Note that current Executive members are ineligible for the award.**

Members may either self-nominate or nominate another member. All nominations will be evaluated by the AIHA BC Yukon Local Section Executive. As a repository and disseminator of knowledge, programs and services for the industrial hygiene and related occupational and environment health and safety community, AIHA provides or facilitates access to science-based information that individuals and organizations need to ensure that health and safety efforts have moved beyond corrective actions to prevention measures, with potential new health hazards being recognized, evaluated, eliminated or controlled before they are introduced into a workplace or community. This may be achieved by promoting the profession and use of sound industrial hygiene practices through cooperation with governmental, industrial, education and other professional bodies.
